3. Written test (max 60 points)

Candidates are admitted to the written test who, in the overall evaluation of qualifications and of the project, have obtained a vote of at least 40/60. In particular, the following will be evaluated:

- Knowledge and competence of the topic (max 20 points);
- Ability to synthesize and clarity (max 20 points);
- Thoroughness and knowledge of the most recent scientific findings (max 20 points).

4. Interview (max 60 points)

Candidates who have obtained a grade of at least 40/60 in the written test are admitted to the oral test. During the oral exam, aspects concerning the qualifications presented, the written paper and/or the project will be examined and clarified, the scores of which will be distributed as follows:

- Discussion about the future research project (max 40 points);
- Discussion about written text exam and curriculum: capability in summarize the central points and academic qualifications (max 10 points);
- Foreign language (max 10 points).

Minimum score valid 40/60.

The minimum final resulting score valid for the admission is 80/140.

B. APPLICATIONS <u>ONLY</u> FOR EXTRA NUMBER CANDIDATES (FOREIGN CITIZENS GRADUATED FROM FOREIGN UNIVERSITIES)

Only for candidates deriving from supernumerary applications for foreign citizens graduated from foreign universities, in addition to proof of knowledge of the Italian language, the oral presentation of a research project relating to the chosen curriculum is required.

To this end, the candidate must present a project that can evaluate his propensity for research and the ability to independently organize the various phases of the project which must not exceed the maximum length of 8,000 characters (including spaces).

This project, which must be submitted by candidates in order to take part to the call, will not be considered compulsory for the research activity of winner participants.

In particular, the following will be evaluated:

- Knowledge of the state of the art (10 points);
- Innovative aspects of the project (10 points);
- Clarity and completeness of the presentation of objectives, methodologies and potential results (10 points);
- Project feasibility (10 points);
- Relevance of the project to the educational goals of the PhD Course (10 points).
