Evaluation criteria for the admission exam to the PhD in Roman law, Theory of legal systems, Private market law - 39th cycle

The qualifications presented can be sent in self-certification. Documents (in pdf format) must not exceed 5MB in size. The requested documentation must be accompanied by the substitutive declaration of certification and/or the deed of notoriety with handwritten signature (pursuant to articles 46 and 47 of Presidential Decree 445/2000).

Qualifications, project and oral exam will be evaluated according to the following evaluation grid:

1. Titles (max 20 points)

1.1 Degree mark (master's, specialist or single-cycle - max 10 points)

Only qualifications relating to the last 5 years from the expiry date of the call will be evaluated (excluding the degree diploma, which will be evaluated even if prior), deemed congruent with the research topics of the doctoral course of the individual curricula

2.Project (max 40 points)

For the purposes of selection for the research doctorate, the candidate must present a project that can evaluate his propensity for research and his ability to autonomously plan and organize the various phases of the project. The project, in self-produced pdf format, written in Italian or English, must expressly indicate on the title page the curriculum in which the candidate intends to carry out the doctorate and the disciplinary scientific sector on which the project concerns (choice between IUS/01 -Private Law; IUS/04—Commercial Law; IUS/07 - Labor Law, IUS/11-Ecclesiastical and Canon Law; IUS/18—Roman Law and Antiquity Law; IUS/20 Philosophy of Law).

Projects without this indication will not be evaluated.

The project must not exceed the maximum length of 8000 characters (including spaces, excluding bibliography).

The project will not necessarily concern the candidate's doctoral research topic (if admitted); the research project to be carried out during the course will be agreed with the Tutor and approved by the Academic Board.

The project must be divided into: a) state of the art; b) description of the project; c) expected results; d) articulation of the project; e) bibliography. In particular, the following will be evaluated:

- •Knowledge of the state of the art (8 points)
- Originality and innovative content (8 points)
- Clarity and completeness of the presentation of the objectives, methodologies and potential results (8 points)
- Project feasibility (8 points)
- Relevance of the project to the educational objectives of the PhD (8 points)

3. Oral exam (max 60 points)

Candidates who have obtained a grade of at least 40/60 in the written test are admitted to the oral test. During the oral exam, aspects concerning the qualifications presented, the written paper and/or the project will be examined and clarified, the scores of which will be distributed as follows:

- •Discussion of topics related to the research project (40 points);
- •Discussion of the candidate's paper and qualifications: clarity of presentation, capacity for synthesis and scientific interest of the curriculum (10 points);
- •foreign language (10 points).

The test is considered passed with a minimum score of 40/60.

The minimum overall score for admission to the PhD is 80/120.
