#### Research project (max 45 points)

In the research project, the candidate must demonstrate clear abilities to design, organize and develop the scientific research in total autonomy. The full text must not exceed 8,000 characters (excluding spaces). This project, which must be submitted by candidates in order to take part to the call, will not be considered compulsory for the research activity of winner participants.

The project, in self-produced pdf format, written in Italian or English, must expressly indicate on the title page the curriculum in which the candidate intends to carry out the doctorate and the scientific disciplinary sector on which the project relates (to be chosen between IUS / 01 - Private Law, IUS / 04 - Commercial Law, IUS / 11 - Ecclesiastical and Canon Law, IUS / 18 - Roman Law and Antiquity Rights, IUS / 20 Philosophy of Law).

Projects without this indication will not be evaluated.

The project must be divided into:

Knowledge of the state of the art (8 points)

Innovative aspects of the project (8 points)

Clarity and completeness of the specific objectives, research strategy, attainability (8 points)

Feasibility of the project (8 points)

Relevance of the project to the educational goals of the PhD program (8 points).

#### Interview (max 60 points)

Discussion about the research project: (max 40 points);

Discussion about written text exam and curriculum: capability in summarize the central points and academic qualifications (max 10 points);

Foreign language (max 10 points).

Minimum score valid 40/60

The minimum overall score for admission to the PhD is 80/120.
