Vittimizzazione secondaria: proliferazione di un fenomeno contrario ai diritti umani In the decision under review, the European Court of Human Rights condemned Italy for the violation of art. 8 ECHR, which protects private and family life. In this particular case, the Court had to rule on the sensitive issue that arises when a clash between the interests of the offspring and the parents has occurred and it becomes necessary to fairly balance them. The ruling, while mainly dealing with the composition between the best interests of the child and the issue of bi-parenting, offers insights with regard to a number of additional matters, such as the secondary victimization, the means to combat it and the systemic flaws that have fostered its alarming spread.


